Notification for prior approval for a change of use from storage or distribution buildings (Class B8) and any land within its curtilage to Dwellinghouses (Class C3) and any land within its curtilage to Dwellinghouses (Class C3).

A letter had been received from local residents who were also present at the meeting.

Discussion included:

- the loss of employment opportunities
- the Neighbourhood Plan desire to protect small employment sites,
- the residents welcomed residential use for the site but wanted further consultation opportunity for the detailed plans.
- the statutory legislation covering this change of use application seemed very limited with little opportunity for refusal/consultation.

The following comments were proposed, seconded and unanimously agreed.

"Mendlesham Parish Council acknowledge receipt of this notification regarding change of use at Buces Farm.

We regret the loss of a small employment site to residential. However we acknowledge that this appears to be in accordance with recent changes in planning legislation.

With this building being a one time part of the curtilage to Buces Farm, a grade 2 listed building, we expect that any alterations to the warehouse are sympathetic to the setting of Buces Farm and this rural environment.

We would also request detailed conversion proposals, when available, so we have a further opportunity to provide consultee comments. "
