SportsCourts £3,789.80. This is the final invoice, only retention left £2,116.60.- Gravity Engineering £43,837.50. This is the one and only invoice, only retention left £1,112.50.

The latest project costs summary shows £6,853.63 left from the MSDC grant offer. This includes the retention, so £3,624.53 left to cover the landscaping, signs, bins and seating. Landscaping and signs are the priority.

- ii) Any other matters: Unauthorised use of the Muga was discussed. The security fencing and warning signs were still in place. It was agreed to communicate further via E News that the areas were not open and to move forward as quickly as possible to complete the landscaping, existing trip hazards and then open.
