An Ordinary Parish Council meeting was held in the Old School Room, Mendlesham, Wednesday 5 October 2022 at 7pm.

# 9f Community Charity events- to agree hire of playing field formalities, including fees.

Discussion related to the Mendlesham Community Charity Community Fireworks event 6.11.22 and the requested hire of Mendlesham Playingfields and associated car parks.

Mendlesham Parish Council unanimously confirmed support for this event but noted further information was required, particularly due to the advert already published including a licensed bar. Discussion included the need for a Temporary Event Notice (TEN) and any requirements or considerations due to the Premises Licence already held by Mendlesham Parish Council.

Some detail regarding food vans and the licenced bar was provided by the Trustee of the Community Charity (member of the public present), including no TEN or Public licence requirement if the event was for less than 500 people.

Whilst further discussion was ongoing, the Trustee/Member of the public left the meeting.

It was then agreed:

- a) Further research was required to confirm the licensing responsibilities, both in the name of Mendlesham Community Charity or their representative to also include implications to the full Premises licence in the name of Mendlesham Parish Council already in place. **Action: Clir Allen.**
- b) There would be a need for all rubbish to be cleared before 8.30am and the start of the following school day which should should include the food/drink businesses clearing up and removing their refuse/litter from the site.
- c) The standard playing field hire Memorandum of Hire would need to be completed, plus any additional requirements specific to the event.
- d) The hire fee of £10 per hour would be applicable. It was questioned if the policy still included the fourth hour of hire as free?

**Action: Clir Davey and Clir Allen** to agree the way forward for further communications by the Clerk regarding hire of this event. noting the event was before the next Ordinary Parish Council meeting.
