Members of the public raised the following concerns and questions: Access for users of the 50 50 shop building – it was confirmed that users could resume use pending following advice on the fire risk assessment. PC container for storage, contents need addressing – confirmed this is in hand. A Cllr to take this forward and action approved disposals. Hot water in the changing rooms showers is a continued issue for users – the PC to investigate and liaise with main users to resolve.

Football pitches had been marked before grass being cut the following day – PC advised unfortunately we have no input on when the contractor can come.

Repair is needed to one of the platforms on the toddler play equipment at Mendlesham Playingfield as the edge has been worn through use – ACTION CLERK: contact the contractor to undertake repair work. Area of 'shrubs' planted on a slope to the side of the MUGA, next to the car park, in need of weed clearing again. Suggested that this area needs to be addressed going forward – PC agreed for this to be an agenda item at the next meeting.

There are notices around the playingfield with the previous clerks details on, these need to be updated – ACTION CLERK to create new notices
