Birketts have been asked to expedite the creation of the lease (at the time of writing they have advised this will be done for us to approve at the meeting 8th January).

The Scouts have asked if the PC would be able to formally approve the Scout Group commencing with the car park/entrance area if the lease is

not resolved so that this will enable them to contact MSDC and hopefully still secure the grant.
