SUPPORTING STATEMENT TO THE ACCOUNTS AS AT 31 MARCH 2019

1. **BORROWINGS**

During the year ending 31.3.13, the Council received a loan advance from the Public Works Loan Board to finance a replacement street lighting project. This borrowing was approved by the Department for Communities and Local Government 1.5.12 ref 2012-13 (10). The original amount of the loan drawndown was £34000 over 20 years, £1129.27 half yearly repayments on 5th January/5 July, with a fixed interest rate 2.93%. The amount of the loan outstanding as at 31.3.19 was £25,033.34.

2. **LEASES**

At 31 March 2019 no leases were in operation

3. **OUTSTANDING DEBTS**

At 31 March 2019 amounts of £30 were outstanding and due to the Council. £100.96 net was due to HM Revenue and Customs due to duplication of vat reimbursement for two items totalling £ 539.31 with reimbursement outstanding 1.2.19-31.3.19 £438.35. The ages of these debts were:

5. **SECTION 137 / POWER OF COMPETENCE PAYMENTS**

Section 137 of the Local Government Act 1972 enables Parish Councils to spend up to the product of £7.86 per head of electorate for the benefit of people in the area on activities or projects not specifically authorised by other powers. With an electorate of 1169, the limit for this Council in the year ended 31 March 2019 was £9188.34. No Section 137 Payments have been made in this financial year because the Council passed a resolution on 19th May 2015 that Mendlesham Parish Council was eligible to use the General Powers of Competence (Prescribed Conditions) Order 2012 and until the Annual Meeting of Mendlesham Parish Council after the next ordinary election, Mendlesham Parish Council is eligible to use the Power of Competence.
