# MENDLESHAM PARISH COUNCIL SUPPORTING STATEMENT TO THE ACCOUNTS AS AT 31 MARCH 2022

#### 1. BORROWINGS

During the year ending 31 March 2013, the Council received a loan advance from the Public Works Loan Board to finance a replacement street lighting project. This borrowing was approved by the Department for Communities and Local Government 1 May 2012 ref 2012-13 (10). The original amount of the loan drawdown was £34,000 over 20 years, £1,129.27 half yearly repayments on 5<sup>th</sup> January/5 July, with a fixed interest rate 2.93%. The amount of the loan outstanding as at 31 March 2022 was £20,287.27.

### 2. LEASES

At 31 March 2022 no leases were in operation

# 3. OUTSTANDING DEBTS

On 31 March 2022 amounts of £853.62 were outstanding and due to the Council. £834.46 VAT claim was due from HM Revenue and Customs for vat paid for the period 1 March 2022 to 31 March 2022. £19.16 outstanding allotment rents. The ages of these debts were:

**Less than 3 months old:** £834.46 VAT paid to be reimbursed. Funds received 7 April 2022.

More than 3 months old: £10 allotment rent considered bad debt. £9.16 allotment rent considered recoverable.

# 5. SECTION 137 /POWER OF COMPETENCE PAYMENTS

Section 137 of the Local Government Act 1972 enables Parish Councils to spend up to the product of £8.41 per head of electorate for the benefit of people in the area on activities or projects not specifically authorised by other powers. With an electorate of 1201, the limit for this Council in the year ended 31 March 2022 was £10,100.41. No Section 137 Payments have been made in this financial year because the Council passed a resolution on 15th May 2019 that Mendlesham Parish Council was eligible to use the General Powers of Competence (Prescribed Conditions) Order 2012 and until the Annual Meeting of Mendlesham Parish Council after the next ordinary election, Mendlesham Parish Council is eligible to use the Power of Competence.
